Sent Structural Dept would inspect the structure for \$5,500 to identify issues prioritize them and present a probable cost. The following is not included in the above estimate. Then Architecture estimated to cost \$10K, then Mechanical / Electrical / Plumbing estimated cost of inspection \$3800 - \$4200 and then last environmental inspection, No estimate at this time. They would look into any grant funding that might be available to help with the costs. Sending to Foundation for further discussion and make a decision on if we want to sign them for at least the initial structural inspection.

• Economic Development Area (EDA)-(Economic Development Director) -- Darrin Fleener (IL & MN) Unable to make it & Dennis Foldenauer, Area Director for Chicago --- Within dept of Commerce, 200 employees. 27 gov't agencies do some form of economic development. Funnels money from gov't directly to the local programs. Around since 1960s. \$400 Million program. Just awarded \$600 Million for disaster relief the country from hurricanes, fires, flooding, etc. \$30 Million in regular funds go to our region. EDA can help provide improved training equipment for programs in workforce development. Great Lakes Region. EDA Investment programs 1. Economic Adjustment, 2. Public works, 3. University Centers, 4. research & Nat'l Technical assistance, 5. Planning (TRRC has a Long-Term Partnership in this program), 6. Local Technical Assistance and 7. Trade Adjustment Assistance for firms. When applying for grants we need to be mindful of other needs in the area. Work with Darren Fleener before applying for grant to see what might be available. Go to StatsAmerica.org to pull information in or region to see what other counties are doing. Offer referral to other government dept or organization to help find assistance when EDA is not able to assist. Areas eligible are High Unemployment, Low Per Capita Income, Special needs. Weatherization (WX) – Becky Pruden We have 5 Finals with remaining homes done but waiting on the paperwork so we can pay them out. Did some multi-unit facilities 12 units at 1 location and 2 at another across town. If inspections go well, we might try to expand to other counties next year.

CSBG Scholarship program will be available again \$1250 each (1 in each county) and is open to be used for tuition, books, housing, etc.

Schuyler County United Way awarded \$5,500 this year (received on May 7<sup>th</sup>)

Alley at outreach in Pittsfield will be replaced in the coming weeks.

Rachel went to a Feeding American meeting and was given food form Walmart form this program.

Carolyn Chaney resigned from case worker position in Brown/Schuyler county after 22 years.
